

Bedford Ouchhh Competition – Terms and Conditions

- 2. Information on how to enter and prizes for the *Bedford Ouchhh Competition* form part of these conditions of entry.
- 3. The promotional period is five (5) days and commences at noon on Thursday 28 July 2022 and closes at 5pm on Tuesday 2 August 2022.
- 4. The promotion is open to residents of South Australia who enter the *Bedford Ouchhh Competition* within the promotional period.
- 5. Bedford Group employees, volunteers and their immediate families are ineligible to enter.

The judges' decision will be final and no correspondence will be entered into.
